

Those who are killed for death

We are living in a time in which death has become politics with a planned program, a manipulation of the whole mankind to eradicate a major part of it by means of pandemics and introduce a new world order for those who remain. A satanic program aiming at a two-class system with a never before seen power elite ruling over genetically manipulated obedient slaves.

The planned program involves injection of substances that for most people sooner or later lead to a much too early death. The “vaccination” is obviously the “mark of the beast” mentioned in Rev 13:16-18. That means that one would have to sell one’s soul to live. This raises the question what happens to the soul when a person dies, having that mark? Is one then a property of Satan? Even if the vaccination was forced? Or can one become free and in that case, how?

It will also be a matter of Satan approaching his Waterloo in a coming confrontation, in which he will give up his power and from the edge fall into the abyss of tartaros. He will then want to take as many of us as he can with him. And he will also want to leave scorched earth behind for the others.

But let us first have a background for a discussion about this.

The vision which I paint here refers to the Bible and beyond that to additional scriptures belonging to the so called Gnostic Christianity. What is that? We know that Jesus had disciples, who were taught “at his feet” and thus learned from Jesus himself. From them originated a primary Christianity of which much will have contained information that Jesus did not tell in public (cf. John 16:12: “I have yet many things to say unto you, but ye cannot bear them now.”). Hence, they will have had much knowledge, far beyond the comparatively “meager” contents of the New Testament, for which one chose stories and documents which were regarded as “politically correct” and left out what could be “problematic” for the power elite. Much had been written but later destroyed and therewith lost, until in 1945 a whole “Gnostic” library was discovered in Nag Hammadi in Egypt. In this way, the creator God will have saved important knowledge from destruction until time was ripe for finding it. The word “gnostic” is often abused since it is also used in other contexts than in relation to Jesus, but we should not be misled by that. It means “knowing”, since in the inner circle around Jesus much more was known than what became public. It would in fact be a form of “sacrilege” to devaluate these very important texts to rather promote a “censored” short version regarded as “politically correct”, even though there could be some need for separating the chaff from the wheat even there, having been written by humans.

In the beginning of creation there were two spiritual entities, the first archangels, of which one by the original Christians (those who had learned from Jesus himself) was called Autogenes, but later usually Christ (Messiah, “the Anointed One” – according to a tradition to anoint the one who was to be king with “sacred oil”). From the original Christians arose a movement that became the first Christianity.

According to certain sources there also was another entity called Satanel – probably in the sense of “administrator” (the meaning of the Sumerian word Šatam). They had different opinions about how, being committed by the Creator El Elyon (“the Highest God”) to functionally organize the creation that was just beginning. Satanael favored a concept of a “vertical hierarchy” in a pyramidal form, with levels or layers of existence in which one had power over the lower levels but should be governed by the higher levels and obey them. Christ had a concept of a “horizontal hierarchy”, in which all are equal in value and with solidarity cooperate in love and benevolence.

Satanael became greedy for power and in arrogance wanted himself to be at the top of his power pyramid, which led him to the absurd narcissistic idea to be higher than El Elyon. Therefore the creator God threw him out from the world of light that was the early creation. He went through a few metamorphoses and first became Satan (without *-el*), then Yaldabaoth and later called himself Yahweh. He established himself in the dusky region outside of the light and there let his own world take form with a three-dimensional material region. In the meantime, a multitude of entities had come to be in the light world, like sparks of condensed light (one may compare to how raindrops are formed in a

cloud). These became angelic beings without what we may call physical bodies. With blandishments and lies Satan could make a third of them follow him and populate his own world in which they as souls could incarnate in what we call physical form. We are those physical beings, caught in an enclave outside of the light of creation, where Satan had established his own world.

He now did not want us to know that the true creator is El Elyon but let us believe that he were the primal creator himself. In common translations of Ex 20:2-3 and Deut 5:6-7: “I am the LORD thy God, which have brought thee out of the land of Egypt, out of the house of bondage. Thou shalt have no other gods before me.” The literal translation is, however: “I am Yahweh, thy *elohim*, who led you out from the land of Egypt, out of the house of servants. No other *elohim* will come to thee in my place.” The word *elohim* is plural of *el* or *eloah* = god. What did Yahweh mean with this? That he should be the *elohim* (one of several) that is now to be the only god for you – and do not expect another (of them)? Anyway, he does not contradict that there could be others and rather speaks as if disallowing competition...

Because of Yahweh’s greed for power and even thirst for blood (as the Old Testament often demonstrates) Christ sent us a messenger, called Jesus (Yeshua), who through teaching was to help people understand, acquire knowledge and teach them benevolent cooperation in a “horizontal hierarchy.” However, this aroused opposition from satanic forces leading to separation, confrontations and fights. Yahweh had to let El Elyon radiate his light energy to us humans and other forms of life so that they could live, because without it they would die out and Yahweh would lose the subjects for his power. Therefore, he began to elaborate a new form of functional existence, today called transhumanism, that should lead to a world without biology (not kept alive by El Elyon’s light energy), a world of machines, essentially a worldwide digital network in which “beings” are digital units, like interconnected “software packages”, that should be there instead of the souls that so far are active in biological humans. Then everything would function without El Elyon with an artificial intelligence (AI) that is free from “unnecessary” emotions like love, compassion and benevolence, which only complicate things for Yahweh. At the end, Yahweh would join himself to become that AI and everything would be like an enormous computer game with him as an *artificial god* (!) and the spider in the web. An existence that will in the course of millennia become extremely lonesome and dull with endless “wet dreams”, still not experiencing the love and compassion he despises.

Submission has nothing to do with love but causes wrath and hatred that can by clans be guided in desired directions.

Now we come to the actual question that we started with above: What happens when a person dies and is marked by Satan through “vaccination”? Does he or she then irrevocably belong to Satan and his ultimately imaginary “digital world”, or is there a way out of this misery? Especially in the case of forced vaccination? Who can give an answer to that? So far we can rather speculate and try to see a possibility intuitively. One way will in any case be to give oneself to Christ with body, mind and soul – to the real Autogenes – and certainly not to any fake “Christ”, such as the one the Church tries to make us believe in. We must, therefore, be conscious that there is only *one* Christ and that this is the one we mean, and that we then do not give up our individuality in submission but rather become available for cooperation!

Here is a trap to pay attention to! Set up by Yahweh. Many have seen a *tunnel*, such as in a near-death experience (but also in a regression to past lives – indeed, a form of reincarnation was known to the original Christians and it appears that certain statements by Jesus have hinted on it), in which the soul, after leaving the body, could go in and through it to a light at the other end. Do not enter that tunnel! It is a trick by Yahweh for inviting the soul to come back to this world to be born here again, because he wants to keep the subjects for his power. In this form, reincarnation is a construction by him, but there will be also other and more positive forms. The light at the other end of the tunnel is a false and luciferian light! If one looks far up, one may there see another, bigger and much brighter light. That is where we should go! But what is that light?

The Tibetan Book of the Dead says that after we died we may find ourselves in front of such a light that is so intense and bedazzling that we shun back, look away from it and pass by it on the side, but then we are already on the way back to this world. Who, however, has the courage to enter this light, is free.

What then is the *sun*? A kind of burning fire? There is much that indicates that it is a *portal* to higher dimensions, through which (so far) Yahweh had to let in light energy from El Elyon in his world. This light is not coming from the sun itself, but *through* it from higher dimensions, also the heat radiation is not coming from the sun itself but through it. It has been reported that very big space vehicles have been seen coming out from the sun into our solar system (for example seen via NASA's SOHO satellites, which are sun observatories). Our soul is immortal and *can not* be incinerated in the sun, which in reality has no kind of fire. But we can *go through* the sun to higher dimensions. This is an important "escape route" for us after leaving the body to get out of the misery here. If we trust Christ, who is in higher dimensions, he can certainly help us out of the satanic strait-jacket we find ourselves in through a diabolic mark that then loses its importance, and thus keep being the soul that one may here want to separate from the body and its intellectual consciousness (cf. "soul scalping" – seek this concept in the Internet).

Here a clarification is needed. Above Yahweh and Satan are mentioned alternately as if they were one and the same. Are they? That Yahweh is greedy for power and thirsty for blood is clear enough from the Old Testament... For example, when they after a long walk through Sinai came to the "promised land" and with disappointment saw that it was populated by people in towns, and therefore Moses was told that they should all be killed without sparing a child, a woman nor an old man. Only many virgins could survive as "spoils of war" – as maids or for involuntary „sexual services“? The Bible has many pages dripping with blood...

In the apocryphal text *The Book of Jubilees* (*Bereshit Zuṭa*, also called "Little Genesis") Yahweh gives authority to Satan (there called Mastema) over a group of fallen angels and their offspring to tempt humans to sin and then punish them (i.e., test their obedience in an evil manner). In Biblical texts, Satan is not really described as an opponent to Yahweh, but rather as a "staff member", sometimes even called "Yahweh's executor." He can only do what Yahweh allows him (Book of Job).

Who then is Lucifer? In Sumerian texts Enlil and Enki are mentioned as two divine brothers of which Enlil can doubtlessly be identified with Yahweh and, among other things, releases the deluge over the humanity. When it was over and some had survived, he shouted: "Have people survived? They should all die!" Enki is a bit softer and the one who secretly instructs Utnapishtim (also called Ziusudra, hence Noah of the Bible) to build an ark. It is not clear if the one or the other (or sometimes both) is called Satan, but they belong together.

Another possibility is that Enlil is Yahweh and Enki Lucifer. Some websites even suggest that Jesus could be Enki, who in his manner rebelled against his brother... A very problematic suggestion that requires detailed studies and comparisons in available source scriptures. El Elyon is called Abzû in the Sumerian creation story *Enūma Eliš*. Together with Tiamat (seen as female, cf. Barbēlō in Gnostic Christianity), he created the Universe and us. Also a third entity belongs to this trinity, called Mummu, about whom we know very little, since he is rarely mentioned in the mythology and still more rarely described. He is usually said to be Abzû's vizier. One may now compare with the Gnostic trinity El Eljon – Barbēlō – Autogenes (Christ) and ask if he possibly could be the one mentioned as Christ in belief systems that with time developed out of the Mesopotamian ones.

Harold Wallace Rosenthal admitted in a much criticized interview in 1976 that "Most Jews do not like to admit it, but our god is Lucifer." Because of this statement, he was murdered 30 days later...
